Please fill out the application form in clear, legible English.

Please attach copies of the passports for the groom, bride, and her Wali with this application.

Please carefully read the following requirements for the day of the Nikah and bring the relevant documents with you.

Requirements:

1. Both bride and groom must be UK Residency and present in person on the day.
2. If any party has non-British Nationality, they must produce a civil Marriage Certificate or approval of Marriage from the Home Office prior to Nikah
3. Both Parties should be affiliated to the Sunni Sect (Ahle-Sunnah-Wal-Jamaat)
4. Nikah to be performed only by the Masjid Imam appointed to conduct the ceremony
5. The Wali must be present in person.
 - The Wali must be the father unless he is deceased; if there are issues concerning the Wali, please call the office to discuss.
 - If the Wali is abroad, he must give power of attorney (official letter attested by solicitor), appointing someone else to act as Wali on his behalf. The power of attorney should clearly state the name of the father, his passport number, and that he is giving his consent for his daughter and the groom to marry.
6. Proof of residential address must be provided for both bride and groom.
7. Two adult, male, Muslim witnesses are required to be present at the Nikah.
8. **If the bride has previously been married, then proof of her Islamic divorce must be provided with this application.**

We require both the bride and groom to be of British or EU nationality. If one or both are not of British or EU nationality, then we require a right to live in UK, or proof of a share code to prove your immigration status.

Please note that the **BCET** recommends very strongly that Muslim couples have civil marriages as well, to help protect the rights of both parties.

If the above requirements cannot be met, the BCET reserves the right to refuse to perform the Nikah.

Please provide payment when the application has been accepted by the Office.

Details of Payment:

Payments should only be made once the application has been accepted by the office.

A fee of £101 is payable when the Nikah is conducted at the office during office hours unless otherwise agreed
